

IT IS BEING NOTIFIED that by a decree dated 23rd October 2014 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Miriam Hayman LL.D) following an application by Rosario Caruso dated 8th October 2014 in the case with Compilation number 480/2014:

Versus:

ROSARIO CARUSO, 41 years, poker player, son of Salvatore and Giovanna, born in Catania, Italy on the 16th April 1973 and residing at ‘Nuvolo Biancha’, Josef Kalleja Street, Swieqi and holder of Italian Passport bearing number AA1055886;

AUTHORIZED the accused **Rosario Caruso** to cash the cheque bearing number 52328, for the amount of €5,000. This cheque was issued by the Government of Malta in the name of Rosario Caruso and is to be cashed at the Bank of Valletta. This sum shall form part of his annual entitlement permitted by law which is thirteen thousand nine hundred and seventy Euro and twenty cents (€ 13,976.24).

This variation was made following a freezing order dated 29th May 2014 which was duly published in the Government Gazette on 30th May 2014 in terms of Section 22A of the Dangerous Drugs Ordinance , Chapter 101 of the Laws of Malta and of Section 23A of the Criminal Code, Chapter 9 of the Laws of Malta.
