ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Aldo Pistella**, and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta, and of Article 23A of the Criminal Code, Chapter 9, of the Laws of Malta.

AUTHORISED that the accused **Aldo Pistella**, can receive an amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year.
