MARTINO AIELLO, 49 years, unemployed, son of Francesco and Grazia nee' Longhitano, born in Catania, Sicily on the 10th October 1965, residing Portopalo di C.P. via F. Garrano 92 and holder of Italian Identity card bearing number AS 4759564.

ORDERED the attachment in the hands of third parties in general all monies and other movable property due or pertaining or belonging to **Martino Aiello**, and prohibits the said accused from transferring, pledging, hypothecating or otherwise disposing of any movable or immovable property and this according to Article 22A of the Dangerous Drugs Act, Chapter 101 of the Laws of Malta, and of Article 23A of the Criminal Code, Chapter 9, of the Laws of Malta.

AUTHORISED that the accused **Martin Aiello**, can withdraw the amount which will not exceed thirteen thousand, nine hundred and seventy six Euro and twenty-four cents (€13,976.24) per year for his living, provided that the Court must be informed from where the amount will be withdrawn and sourcing of the same.
